



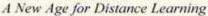
Introduction

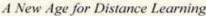

Discipline can be categorized into two types:

Physical discipline is the physical action of a teacher or school principal on students who misbehave, such as using a stick or other means. Although this type of punishment has stopped in many countries, it is still used in some private schools and in many countries. I think this kind of discipline is morally and religiously rejected, because it may increase bad behavior and destroy the student's personality and his respect to himself

3.1- Detention

Detention is a way of punishment in which the student is detained for some time either after school time or on holidays. This none corporal punishment is common in many countries as a way to





force discipline in schools. I believe that this kind of punishment may work well under certain circumstances if applied under control and for short time.

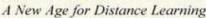
3.2- Suspension is a procedure that prohibits a student from attending school for a certain period. This may have a negative effect on the student, as the student spends his time on the streets and may deviate into street gangs and drug traffickers (Rawlinson, 2018). Or the student will spend his time in workshops where the child is exploited in the cheap labor market. This affects the student's level of science achievement and the level of acquiring knowledge of the student once he returns to

school.

3.3- Counseling either by the school counselor or the family advisor is a good way to correct misbehavior of the student especially if done under the supervision of the parents and away from the student's colleagues.

3.4- Expulsion is the termination of the student education at school, it is the last form of discipline when all other forms have failed. Expulsion stands against Human rights and the right for education for all students. It may encourage some other students to misbehave to escape school and its regulations, so this action of discipline must be done after counselling with parents and if possible with legislative authorities. Excluded students can be collected in private classes or enrolled into vocational education to protect them from street gangs and drug traffickers and cheap working.

3.5- Restorative Justice is a form of discipline where the students are given the chance to discuss their conflict with the rules of school under the supervision of court or law enforcement, they are encouraged to remediate their behavior by admitting their mistakes and reevaluation of their actions. It is a new way of resolving problems rather than punishment. The restorative justice





focusses on building relationship between students and teachers and with the society as a whole, everyone feels that he has a role in building society values.

This action is important for the students as well as for the school and teachers, it will preserves the school discipline rules and preserve the student personality, also it is good for the society as it adds good members into society and prevents students from another misbehavior actions.

3. What are your views about distance education online?

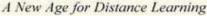
Answer:
